(h) A sufficient supply of clean, dry diapers shall be available, and diapers shall be changed as frequently as needed. Diaper changing shall be documented for each infant and available to the parent.

Explanation of Findings: It was observed during visit on 8/1/2019 by licenser Tresa King that the logs used for recording diaper changes was insufficient, not all changes were recorded and log was not individual to each child.

Action Required: Complete and submit a Corrective Action Plan detailing how documentation for diaper changing shall be documented for each infant and available to the parent.
