The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/06/2019, and investigated by Tresa King

A statement of childcare allegation, CPL-4804, was provided on 09/11/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 2. Capacity/Supervision Requirements

(m) There shall be at least one (1) adult staff supervising the care of children at all times.

Reason: It was self reported on 9/6/2019 that a child was in the classroom without adult staff supervision.

Explanation of Findings: Finding of non-compliant based on self report, and statements obtained from staff interviewed during the investigation. It was confirmed that on 9/6/2019, a child was left in the room unattended for a short period of time before other staff in the building found the child in the hall outside the classroom and re-united the child with group and classroom staff on the playground.

Action Required: Corrective Action Plan is required. Please complete your CAP and submit it to Wyoming Department of Family Services, Child Care Licensing Division, Riverton office.
