The Department of Family Services has completed the investigation regarding alleged violation(s) of the Wyoming Child Care Rules received on 09/19/2018, and investigated by Pamela Konstant

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

- (b) Administrative records shall include:
- (i) Attendance record for each child to include dates attended and arrival/departure times verified by staff;

Explanation of Findings: During an investigative visit of 9/18/18, Licenser observed that the sign in sheets did not reflect the children present at the facility at the time of the visit. There were 4 more children present in the facility who did not show on the attendance record.

Action Required: Facility must maintain accurate sign in sheets at all times for children in the facility. Children must be signed in and out of the facility and of classrooms if they change throughout the day. Staff will verify these sign in sheets regularly to make sure they accurately represent the number of children in their classroom at all times. If both electronic and manual sign in sheets are used, they both must be maintained, verified, and accurate at all times. Facility will provide a Corrective Action Plan on how they will accomplish maintaining accurate child attendance records. Each staff person will be trained in the importance of maintaining these records and the correct way to maintain and verify them.

(i) After using the toilet or helping a child use a toilet, diaper changing, handling bodily fluid, handling pets, cleaning or handling the garbage, or handling food (The kitchen sink shall not be used for hand washing after diaper changing); and

Explanation of Findings: During the investigation visit of 9/18/18, Licenser observed a staff member wipe the nose of a child and not wash their hands before going to wipe another child's nose.

Action Required: Facility will make certain that all sanitation requirements are met and adhered to by all staff. Director and all staff will take an additional 2 hours of education specifically relating to sanitation procedures in child care settings.
