A statement of childcare allegation, CPL-4756, was provided on 06/21/2019.

The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements

Section 2. Capacity/Supervision Requirements

(m) There shall be at least one (1) adult staff supervising the care of children at all times.

Reason: It was reported that unqualified staff have been left alone with children.

Explanation of Findings: A finding of non-compliance is based on staff interviews and records showing that staff was used in ratios without supervision of a qualified staff before pre-service training and facility orientation was complete.

Explanation of Findings: A finding of non-compliance is based on records and interviews with staff showing that Annie Kerns and Tara Underwood began working in the facility on 6/14/19 before fingerprint results returned on 6/18/19.
