The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

(b) Staff:child ratios and supervision requirements as described in this chapter shall be maintained at all times.

Explanation of Findings: It was observed that on October 22, 2019 the facility was out of compliance with staff:child ratio requirements. One staff member was alone with one infant, 3 one year olds, 2 two year olds, 2 three year olds, 1 four year and 1 five year old.

Action Required: Immediately cease the practice of allowing staff members to be out of compliance with staff:child ratio requirements. Ensure that all staff members understand staff:child ratio requirements and how children under the age of two impact ratios. Complete the enclosed corrective action plan detailing how the facility will maintain compliance with staff:child ratio requirements at all times in the facility.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
